Teams that have fished at least six qualifying tournaments and are in good standing are invited to attend the 2010 Team Bass Tournament Series Tournament Of Champions (T.O.C.) A complete list of T.O.C. qualifiers will be posted on the website no later than September 1st.

This years T.O.C. will start with official practice beginning Monday 9/20 thru Friday 9/24; ending at 2:00 p.m., Friday. Any teams found to have violated this rule will be disqualified.

Saturday 9/25: Pre-tournament check-in starts at 5:00 a.m. at the Lake Dardanelle State Park- Russellville tournament weigh-in facility. Teams must have their livewell checked and tagged. Take off will be at safe light. Check-in for Day One weigh-in will begin at 3:00 p.m. Day One weights will be registered and the results will be posted and given to teams with the closing of the scales.

Saturday Night 9/25 at 7:00pm: Teams are invited to attend dinner at Western Sizzlin, 1105 E. Main, Russellville. Dinner will be available with 3 choices for main course meals and drinks free to those attending. Please indicate on the registration form if you and your partner plan to attend. The AOY Team Award will be awarded and the 2011 Season announcements will be made.

Sunday 9/26: Pre-tournament check-in starts at 5:00 a.m. at the Dardanelle State Park- Russellville tournament weigh-in facility. Teams must have their livewell checked and tagged. Take off will be safe light in the reverse order of Day One. Check in for Day Two weigh-in will begin at 2:00 p.m. Day Two weights will be registered and a combined total of results will be posted and given to teams with the closing of the scales. Awards will follow after the closing of the scales.
